ORDER:

As per the orders of the Vice-Chancellor, Dr. NTR University of Health Sciences, and as per the statutes on affiliation of Medical colleges of Dr. NTR University of Health Sciences, Vijayawada, it is hereby certified that the application of **Apollo Institute of Medical Sciences & Research, Murukambattu (V), Chittoor District** has been registered with the Dr. NTR University of Health Sciences, Vijayawada and continuation of provisional affiliation for the academic year **2021-22** is granted and permitted to make admissions into **MBBS course** at **Apollo Institute of Medical Sciences & Research, Murukambattu (V), Chittoor District** with an intake of **150 students (one hundred fifty only)** as per rules.

The Undergraduate Medical Education Board, National Medical Commission, New Delhi has granted recognition of the MBBS degree awarded by Dr. NTR University of Health Sciences, Vijayawada for intake of **150 students** of **Apollo Institute of Medical Sciences & Research, Murukambattu (V), Chittoor District** admitted in the academic year 2016-17 only U/S 11(2) of IMC Act, 1956 and section 35(4) of the NMC, Act 2019. The recognition so granted to an Undergraduate course for award of MBBS degree shall be for a period of 1(one) year i.e. for the year 2021-22 only, in view of ongoing covid – 19 pandemic.

The Institution / College is fully responsible to fulfill the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of National Medical Commission, New Delhi.

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the National Medical Commission / Dr. NTR UHS.

The fee collected by what so ever name called either for University quota seats or for management seats should not exceed the limits specified by the State Government / Dr. NTR UHS from time to time.

The Management of the college shall follow the regulations made by the University/State Government and also the **Graduate Medical Education Regulations, 1997** of the National Medical Commission in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice.

This order is valid for a period of one year from the date of issue.
